The Geophysical Technologist will support geophysicists and geologists with seismic and well data loading, map updates, geo-referencing, data QC and manipulation, troubleshooting, and general support.

Responsibilities:

The Geophysical Technologist will be responsible for:

Data Management

- Maintenance of the corporate seismic database, server storage, and physical media.
- Maintain SeisInfo database to archive/ find geophysical data.
- Receive geophysical data. Check data format and quality prior to entering in database.
- Generate maps and summaries of corporate data for management and G, G, and E.
- Assist G&G in finding, ordering, and inputting new data from EPIS, BIPE, or other external data sources.

Applications and General Support

Provide geoscience and GIS software expertise for G&G, including data loading (seismic and well data) and transferring interpretation into projects and programs. Ensure quality control for all work.

Understand GIS and geographic coordinate systems and their issues. Troubleshoot positioning errors using available documentation, navigation files, and Lidar.

Assist G&G with required data submission to the government. Send the required data in the required formats. Support data rooms and remote workstations for business development.

Assist geophysicists with survey audit and processing projects. Liaise with data processors, external survey auditors, partners, and external partners.

Maintain and update G&G projects in Petrel, SeisWare, Geographix, and Kingdom.

Work with the IT department in troubleshooting G&G software issues with G&G team members.

Support/collaborate with co-workers in Calgary, Bogota, and Quito corporate offices.
